# Institute Expenses and Scholarship Information

The total costs for the Institute are \$1993 per person for graduate credit or \$1345 for undergraduate or CEU credit. This fee includes 4 hours of graduate credit, 3 hours of undergraduate credit or 4.5 continuing education units, as well as faculty pay and travel, instructional materials and textbooks, facilities, coffee breaks and six lunches, administration and fundraising expenses. **We have been doing extensive fundraising and will be able to give scholarships of \$850 to each participant. The remaining charge of \$1143/graduate or \$495/undergraduate & CEU will be the responsibility of the participant and/or sponsoring school/group.** We are arranging for housing at a nearby hotel or university dorm at a reasonable nightly rate. Travel expenses are up to the individual and will vary considerably.
